**REQUIREMENTS:**

- Must pay in advance by credit card base rate (\$125). Rate is valid 7am Monday to 7pm Friday. Rate is \$150 from 7pm Friday to 7am Monday
- All additional costs (groceries, med's, etc.) incurred are client's responsibility
- Patient must be capable of being transported in a car
- Additional time required will be billed at personal care service rate
- Auto mileage fee is .60/mile after first 25 miles

# Services Overview



## **Initial Assessment**

**Free**

Nurse or Care Coordinator to meet with family and determine personalized care needs.

## **Personal Care Services**

**\$24-28 / Hour**

Hands-on assistance with bathing, hygiene, incontinence care and companionship, errands and transportation. Subject to a 4-hour minimum.

## **Professional Nursing Consultation**

**\$65.00 / Hour**

Hourly skilled care, special assessment and oversight needs for chronic disease management. Rate valid 7am Monday to 7pm Friday. \$57.00/Hour from 7pm Friday to 7am Monday.

## **Professional Nursing Care Visit (Ohio only)**

**\$70.00 / Visit**

One hour professional nursing care visits, medication set-ups, or wound care. Rate valid 7am Monday to 7pm Friday. \$80.00/Visit from 7pm Friday to 7am Monday.

## **Couple Care**

**\$28.00 - \$36.00 / Hour**

Care for two persons living together may be provided for a significantly reduced rate. (Subject to assessment to determine level of care required for each person.) Rates valid 7am Monday to 7pm Friday. \$27.00-\$32.00/Hour from 7pm Friday to 7am Monday.

## **Medication Management (Ohio only)**

**\$70.00 / Visit**

Registered Nurse set-up and management of refills for all aspects of medication management. (Available weekdays only)

## **Transportation**

**\$32.00 / Hour + .60 / Mile**

Client must be capable of being transported in a car. Wheelchairs must be foldable to allow stowing in the car's trunk. Minimum is 4 hours, paid in advance.

## **Alzheimer's and Dementia Care**

Caregivers who have received **Teepa Snow Training Certification** dementia-specific training and can administer activity-based programs that are available to enhance daily life for persons with dementia. These services are billed at our regular personal care services rate.

## **Hospice Supportive Care**

Supplemental personal care services provided for individuals who need extra custodial care between regular hospice visits. Caregivers have received training in the care of bed-bound patients, comfort care, pain management as well as the emotional and social support needed at the end of life. These services are billed at our regular personal care services rate.

## **Patient Advocacy Services**

Caregiver or nurse to be present and monitor individuals while experiencing a hospital or skilled nursing admission. These services are billed at our regular personal care services rate or our nurse rate.
